# MINUTES OF THE YARM MOTORCYCLING CLUB AGM HELD ON 8th JANUARY 2020 AT THE CLEVELAND BAY, EAGLESCLIFFE

- 1. <u>Opening Address</u>. The Chairman opened the meeting, welcoming the members to the AGM. He asked that members address all matters through the Chair. Before continuing with the meeting the Chairman had an announcement to make:

- 8.1 Would all members please confirm their email addresses when renewing their membership
- 8.2 BMF Affiliation. The club has renewed it's affiliation to the BMF for 2020 & had received a letter of thanks for prompt renewal. Affiliation provides a number of benefits/discounts as well as covering the club for certain legal proceedings following any event that the club has sponsored or attended. .
- 8.3 The committee had earlier decided to issue all members with updated business cards so that these could be given to prospective new members or those wishing to visit.
